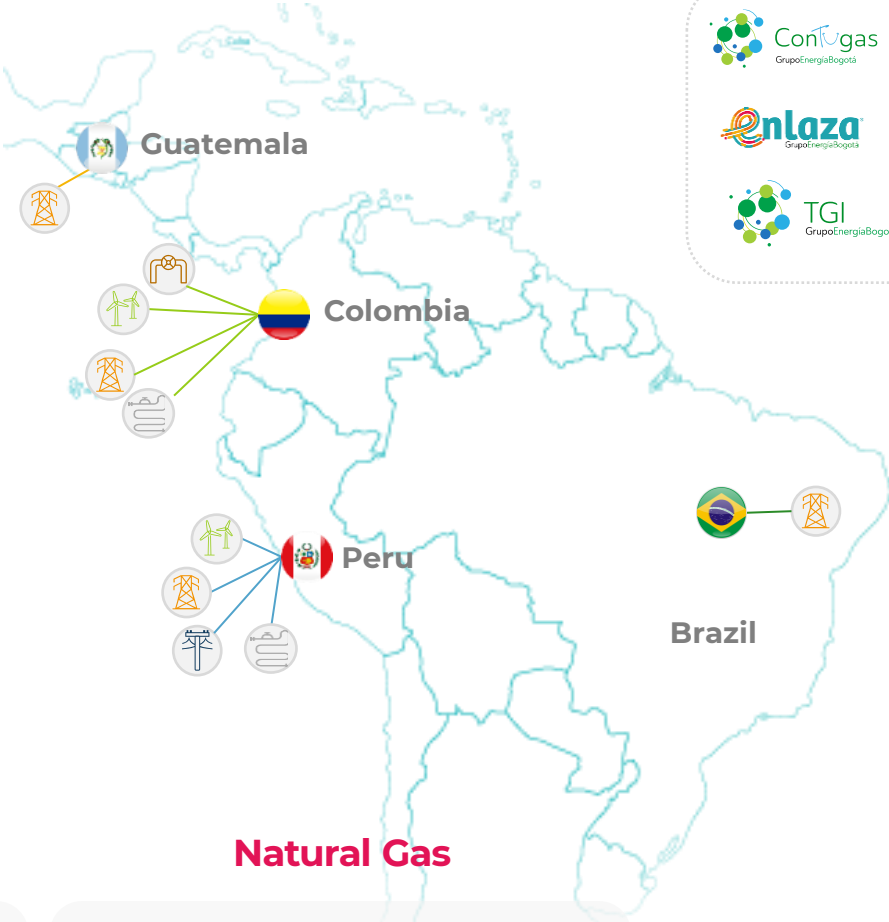

TGI Key 2025 Goal:

- Position natural gas as an essential fuel to achieve a fair, inclusive and economically efficient energy transition

Green Corridors:

- Consolidate «Green Corridors» connectivity model where our infrastructure is present

Conservation (2023-2025) including:

- Maintain initiatives for the monitoring and conservation of native species

Targets by 2025 including:

- Structure social impact bond for employment education in Bogotá
